EvaluatePanel Evaluate a panel

### Description

Transfer the input allele frequency data (in a .csv file or a data frame) into form usable for other functions and then calculate several population parameters based on the frequency data for each marker.

#### Description

LR when a child (C) is alleged to be a grand-child of another individual (GP), and an offspring(A) of the alleged grandparent participated, with or without the assistant of B's other parent (M). Hp is that, C is an offspring of A's full-sibling; and Hd that, C is unrelated to GP and A. Inbreeding is not considered.

#### Details

If any one of TP or AR cannot provide any of the C's alleles through integer steps, muAtoC would be output when calculating PI, and under other situations, the case with minimum mutation steps, (AR to C)+(TP to C) under Hp and (TP to C) under Hd, would be considered. Much more is required for further discussion in PI calculation involving mutations.
